### Financial Planning

There have been a number of Superannuation Contribution changes that will come into effect from 1<sup>st</sup> July 2017.

- The Concessional Contribution limit is \$25,000 for everybody.
- The Non-Concessional Contribution limit is being reduced to \$100,000 per annum.
